MONTEREY ROAD BRIDGE: 2 easements will be needed so the crane can swing its arm. These will be temporary easements. Town Counsel will draw up the article for Town Meeting for the layout of the road and the taking of the easements.

BROADBAND: Mr. Consolati is working with charter to get the new maps that show the 96% of town that will have internet.

CONSTABLE: Matthew Puntin made a motion to appoint Thomas Fennelly as a constable and James Consolati, seconded.

AIR B & B: Jeremia Pollard will draft an article for insertion to the Annual Town Meeeting Warrant for the town to receive 5.7% tax on the rentals of property outlined in (MGL c. 64 G section 3A) which is collected by the state and returned to the town thru the "cherry sheet". This would need Town Meeting approval.

PAVING OF GOOSE POND ROAD: An email request was received and it asked to pave the dirt portion of Goose Pond Road. It was mutually agreed that the cost to pave that approximately 2 miles of that road is not in the budget.
