

BOARD OF SELECTMEN MEETING

Tuesday May 11, 2021 (following Health meeting). PM 6:12 pm

Board members present: James Consolati, Matthew Puntin & Michael Curtin-Molly Curtin-Schaefer.

Mail was read, previous minutes and treasury warrants were approved.

Mail reviewed: MIIA renewal terms and conditions for FY22, progress report on the Tyringham Hazard Mitigation plan and a quote for a 2021 Deere 310SL HL backhoe loader.

MAGGIE HOWARD WAY: Nini Gilder, Lauria Puntin and Rosemary Renn from the Hop Brook Club proposed that a sign be installed to commemorate the many contributions of Maggie Howard to the Town of Tyringham. This sign is 18" x 18" and will be double sided attached to a pole. A discussion ensued about the location of a sign. The Board of Selectmen unanimously approved that this sign could be installed at the corner of Main Road where the right-of-way crosses between the parsonage and church.

FY22 BUDGET: The Board reviewed the budget for the June 12, 2021 Annual Town Meeting. James Consolati prepared a FYE 2021/2022 comparison spreadsheet. A discussion about borrowing or using stabilization funds ensued and will be decided at the next budget review meeting. A Special Town Meeting will be held on the same day just prior to the Annual Town Meeting to correct a clerical error in the Road Construction account.

NEW BUSINESS: The Board voted unanimously to have Larry Gould send all building permits to the Town Office and once a check is received for the permit, the office can release the permit.

HEARING – Cobble Farm LLC applied for a new license for a General On-Premises All Alcoholic Beverages permit. (The full application is on file at the Town Office). *Selectman Michael Curtin excused himself from the Board due to a possible conflict of interest and sat in the audience.* Attorney Lee gave an overview of this application and Mr. Nicholas Felix also reaerated the application. The Board asked if anyone had any comments. Mr. Leiderman asked about noise and impaired drivers. Attorney Lee offered him a copy of the application. Mr. & Mrs. Henning Carlson stated they had no objection. James Consolati made a motion to approve the application and Matthew Puntin seconded, no opposition.
